2. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

DANGER. CORROSIVE. CAUSES SKIN AND EYE BURNS. HARMFUL OR FATAL IF SWALLOWED.

4. FIRST AID MEASURES

Eye contact: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Get medical attention immediately.

Skin contact: Take off contaminated clothing. Immediately flush with plenty of water for 15-20 minutes. Get medical attention immediately.

Inhalation: If breathing is affected, remove to fresh air. Get medical attention immediately.

Ingestion: Call medical attendant, doctor, or poison control center immediately. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Never give anything by mouth to an unconscious person. THEN IMMEDIATELY CONTACT A PHYSICIAN OR POISON CENTER.
