I. INGREDIENTS

III. FIRE HAZARD

IV. REACTIVITY DATA

Enviro Care All Purpose Cleaner is stable and non-reactive.

٧. **HEALTH HAZARD DATA**

The principal route of exposure to Enviro Care All Purpose Cleaner is skin contact. Incidental skin contact is not expected to cause any significant irritation. Prolonged skin contact or eye contact may cause mild irritation.

Enviro Care All Purpose Cleaner is not listed as a carcinogen by NTP, IARC or OSHA.

VI. FIRST AID

For eye contact, flush with clear water for 15 minutes. For skin contact, wash with soap and water. If swallowed, consult a physician.

VII. PRECAUTIONS FOR SAFE HANDLING AND USE

Keep out of reach of children. Avoid eye and prolonged skin contact.

VIII. **SPILL HANDLING**

If Enviro Care All Purpose Cleaner is spilled, recover liquid with wet mop or wet/dry vacuum. Flush residue to sewer with water. Use care, as floor may become slippery.

IX. SPECIAL PROTECTION INFORMATION

Protective equipment is not normally required. If desired, rubber, neoprene or vinyl gloves may be used to minimize skin contact. Splashproof chemical safety goggles may be used to eliminate the possibility of eye contact.
