

X-ACTO® and Boston® Pencil Sharpeners LIMITED WARRANTY

Terms of the Limited Warranty

Elmer's Products, Inc. ("Elmer's") warrants to the original purchaser that X-ACTO® and Boston® pencil sharpeners (the "Products") are free from defects in materials and workmanship under normal use and conditions for a period of 10 years from the date of retail purchase. Please note that cutting blades are considered normally wearing parts and carry a 2 year limited warranty. Elmer's agrees to repair or replace, at Elmer's option, any defective Products. This limited warranty is not transferable and covers only damage resulting from defects in material or workmanship. This limited warranty does not cover conditions or malfunctions resulting from normal wear, neglect, abuse, accident or repairs not carried out by Elmer's.

To register your Product and activate your limited warranty, complete the warranty card and mail to Elmer's Products Inc. at the address provided on the warranty registration card. For warranty handling instructions, please contact Elmer's Products, Inc. customer service at 1-800-879-4868. At Elmer's discretion, you may be required to return the defective Product in the original packaging or packaging offering comparable protection. If the requested service is covered under the terms of this limited warranty, the item will be replaced or repaired at Elmer's sole option and returned to you without any charge.

If you have a problem with the materials or workmanship of this sharpener, we will repair or replace it free of charge while the product is under warranty. Cutter parts are under warranty for up to 2 years from the purchase date; all other parts for 90 days from purchase date. 7 Year Limited Warranty - U.S.A. and Canada Only

Effective December 1, 2005 Bostitch® L.P. warrants to the original retail purchaser that the product purchased is free from defects in material and workmanship, and agrees to repair or replace, at Bostitch's option, any defective Stanley Bostitch® branded office product (7) years from date of purchase. Warranty is not transferable. Proof of purchase date required. Driver blades, sharpener cutters, punch heads, and cutting discs are considered normally wearing parts.
