

# Funding Opportunities and Reference Guide: Emergency Connectivity Fund

## Who is Eligible:

- Schools
- Libraries

## Eligible Usage:

- Educational Only  
*One connected device per user.*

## Eligible Services:

- Broadband Services

## Eligible Equipment:

- Wi-Fi hotspots  
*Capped at \$250 per device.*
- Modems
- Routers
- Connected Devices (Laptops, Tablets, Chromebooks, iPads)  
*Capped at \$400 per device.*
- School Bus Wi-Fi

## Frequently Asked Questions:

When do products and services need to be delivered to qualify for support?

July 1, 2021, through June 30, 2022

→ Is there a limit on reimbursement amounts or a Price Cap?

\$250 is the maximum reasonable cost for a Wi-Fi hotspot.

→ How do CIPA laws impact ECF? (Internet Filtering)

The CIPA requirements will apply.

→ Does my organization still qualify if we previously received support? (ESSER/ CARES)

The FCC will not provide support for eligible equipment and services that have already been reimbursed through other federal pandemic relief program.

→ How long do I need to keep my records for purchases?

A minimum of 10 years.

**Purchasing Timeframe:** July 1, 2021 - June 30, 2022

**Amount:** \$7.17B

**Application Process:** Applications will be submitted in the E-rate EPC Portal and will utilize Form 471 and Form 472 BEAR.
